## **PACAF: SHARING OF AUDIT PLANS**

The attached schedule is based on information that has been provided to PACAF by organisations via their respective regional procurement and contract audit group. It identifies those audits that are included within their annual audit plans that are considered to be of a procurement or contract related nature.

Organisations were asked to categorise each audit activity according to:

- The ProClass classification which is used by many organisations to analyse their expenditure; and
- The standard top-level audit programmes that have been developed by PACAF for reviewing an organisation's control environment.

The attached schedule therefore identifies those audits included in the audit plans of participating organisations for each of the ProClass spend areas, which have been numbered [1 to 54] by PACAF for ease of reference, as well as for each of the control environment areas.

The financial years stated in the schedule indicates that an organisation has that topic included in their annual audit plan for that year. The relevant participant organisation for each audit is identified (in the same order) by the letter in the last column. For example:-

- At spend area 13, four organisations are indicated as having included an audit of waste contracts in their audit plans for 2012/13. These four organisations are represented by the letters A; E; F and I.
- At spend area 45, organisation 'N' is indicated as having included an audit of 'Energy' in their 2010/11 plan, while organisation 'E' has a similar audit in their plan for 2012/13.
- Under 'Control Environment Project Management', four organisations (I; H; J & K) included reviews of 'contract management' in their plans for 2012/13; while organisations S and B had included this subject in their plans for 2010/11 and 2011/12 respectively.

The contact details for all of the participants are contained in a separate document which is available only to participating organisations.
